SETTLEMENT AGREEMENT

BETWEEN:

B.C. PUBLIC SCHOOL EMPLOYERS' ASSOCIATION/BOARD OF EDUCATION OF SCHOOL DISTRICT  
NO. 33 (CHILLIWACK)

("BCPSEA" / the "School District")

AND:

BRITISH COLUMBIA TEACHERS' FEDERATION/CHILLIWACK TEACHERS' ASSOCIATION

(the "Union")

Re: Grievance BCTF File #33-2018-0002, Local 33-2018-06 (General – Hours of Work); Local 33-2018-29 (General – District Communication to Middle School Teachers After Grievance Filed)  
(the "Grievances")

WHEREAS the parties have had discussion regarding the Grievances with the assistance of Arbitrator Corinn Bell and wish to resolve all issues regarding the Grievances.

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. The parties will execute a Letter of Understanding regarding Middle School Hours of Work, attached as Appendix "A".

2. To support transition in the 2019-2020 and 2020-2021 school years, students will not be scheduled to attend Support Blocks for the first week of each of those school years, so that teachers can prepare, plan, and collaborate during that time.
3. In the 2019-2020 and 2020-2021 school years, the week preceding winter break will not include Support Blocks, and teachers will not be scheduled for Support Blocks during that time.
4. In addition, in the 2019-2020 school year, the week preceding spring break will not include Support Blocks, and teachers will not be scheduled for Support Blocks during that time.
5. The parties agree that the terms of this Settlement Agreement constitute a full and final resolution of the Grievances.
6. The terms of this Settlement Agreement are without prejudice and without precedent to the position of either party on any other issues in this School District or any issues in any other School Districts.

7. Corinn Bell will retain jurisdiction to resolve any issue or dispute related to the terms of settlement of the Grievances.


