In areas where COVID-19 activity is present, in addition to handwashing and cough		
etiquette, "use of non-medical masks or face coverings is recommended as an		
added layer of protection when physical distancing is difficult to maintain," said		
Theresa Tam, Canada's chief public health officer, on May 20.		
Establish and post occupancy limits for shared spaces, such as lunchrooms and	WS	
break rooms. Consider removing chairs or tables to ensure occupancy limits are		
not exceeded. If possible, provide additional areas for workers to have their		
breaks, including outside areas if available.		
This should have already been done—if not, then it needs to be established.		
In primary grades, physical distancing is difficult to enforce with younger children;	WS	
however, workers should teach appropriate behaviors, consider space limitations,		
and options where possible.		
Where possible, have workers perform only essential tasks to maintain the	WS	
student's education and well-being. Tasks that are non-essential should be put on		
hold until directed otherwise by the provincial health officer.

All sites will have a clear screening process where staff and students are		
asked if they are sick.

assess their children daily before sending them to school.		
Alternatively, conduct daily checks for respiratory illness at drop-off by

of common cold, influenza, COVID-19, or any other respiratory disease.		
Establish procedures for students and staff who become sick while at school		
to be sent home as soon as possible.		
Employers are required to develop a COVID-19 Safety Plan that outlines the	WS	
policies, guidelines, and procedures they have put in place to reduce the risk of		
COVID-19 transmission.		
Limit the public coming into the office. Encourage parents and others to call	WS

Designate a two metre area in front of or behind a kiosk (office windows). Consider	WS	
the use of tape or other floor markers to designate where people can stand and		
line up (if required).		
Plexiglass may be used to separate administrative workers from the public if two		
metres of separation cannot be maintained.		
Train your workers on:	WS	
The risk of exposure to COVID-19 and the signs and symptoms of the disease.		
Safe work procedures or instruction to be followed, including hand washing		
and cough/sneeze etiquette.		
How to report an exposure to or symptoms of COVID-19.		
Changes you've made to work policies, practices, and procedures due to the		
COVID-19 pandemic and keep records of that training.		
Document COVID-19 related meetings and post minutes at a central location.		
Keep records of instruction and training provided to workers regarding COVID-19,		
as well as reports of exposure and first aid records.

surfaces such as doors and cabinet handles, stair railings, washrooms, shared		
office spaces, desks, keyboards, light switches, and communications devices.
