

## SETTLEMENT AGREEMENT

BETWEEN:

B.C. PUBLIC SCHOOL EMPLOYERS' ASSOCIATION/BOARD OF EDUCATION OF  
SCHOOL DISTRICT NO. 33 (CHILLIWACK)

("BCPSEA"/ the "School District")

AND:

BRITISH COLUMBIA TEACHERS' FEDERATION/CHILLIWACK TEACHERS'  
ASSOCIATION

(the "Union")

**Grievance: BCTF File No. 33-2019-0016, Local File No. 33-2017 General – Access to Information**

WHEREAS:

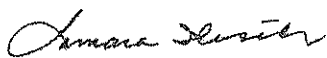
- A. The Union filed the grievance which was referred to arbitration before Arbitrator Corinn Bell; and,
- B. The employer currently provides the following information to the Union:
  1. in October and February of each school year, a list of all teachers' contact information and location ;
  2. on or before October 15 of each school year, a list of all teachers in temporary positions by October 15;
  3. in September and January of each school year, a list of teachers teaching on call.
- C. The parties have reached a resolution of the grievance.

NOW THEREFORE THE PARTIES AGREE as follows:

1. The employer will provide to the union the contact information and location of teachers referenced in clause B.(i.) above in electronic format on an excel spreadsheet;
2. Where it comes to the union's attention that the contact information provided is not correct or is outdated, the employer will provide the updated contact information at the union's request;
3. The employer will provide to the union leave information such as the type, dates and duration of the leave with the consent of the member using the following process:  

The union may request the leave information by email that identifies the leave information sought to be disclosed to the union. The email will be copied to the member who may consent to the disclosure by a "reply all" return email that indicates agreement to the disclosure.
4. This settlement is without prejudice and without precedent to the position of either party on any other issues in this School District or any issues in any other School Districts and is not to be referred to in any other matter or proceeding except to enforce the terms of the settlement.
5. Corinn Bell will retain jurisdiction to resolve any issue or dispute related to the term of this settlement.

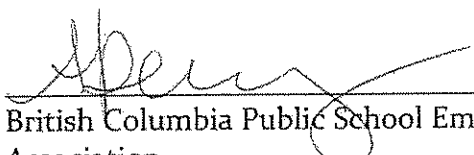

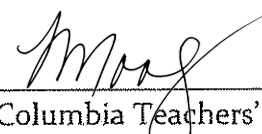
